Prevent work-related injury and ill health



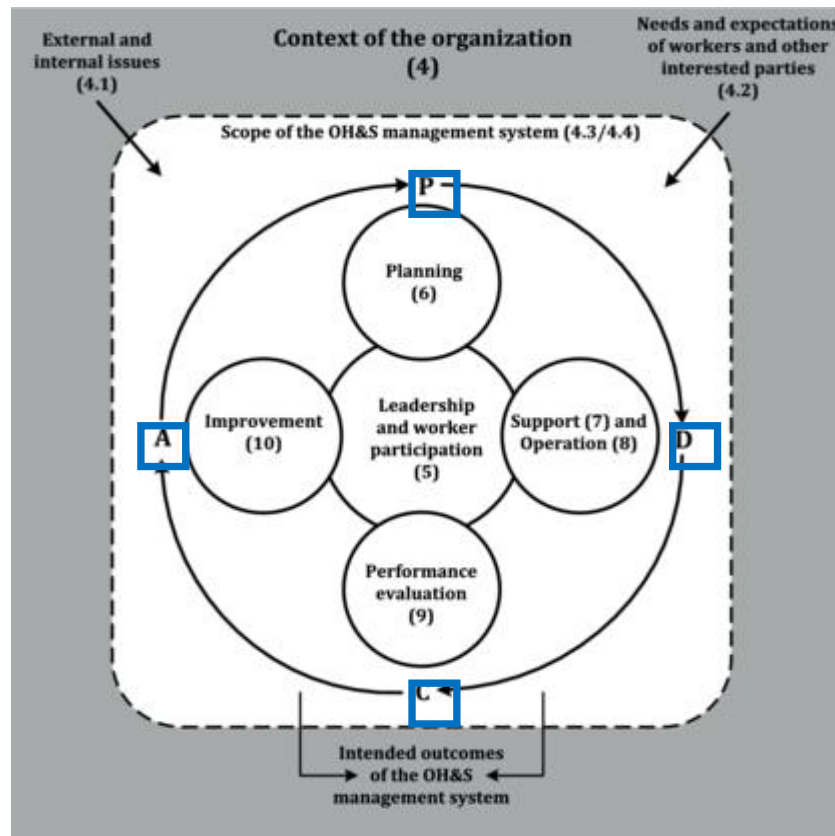
Continually improve the OH&S performance



# 1. An Overview of OHSMS

The OHSMS approach is founded on the Concept of Plan-Do-Check-Act (PDCA).

PDCA is a cyclical process for promoting continual improvement within an organization.



PDCA Model

## PLAN

Determine and assess OHS risks, OHS opportunities and other risks and other opportunities, establish OHS objectives and processes necessary to deliver results in accordance with the organization's OHS policy.

## DO

Implement the processes as planned

## CHECK

Monitor and measure activities and processes with regard to the OHS policy and OHS objectives, and report the results

## ACT

Take actions to continually improve the OHS performance to achieve the intended outcomes

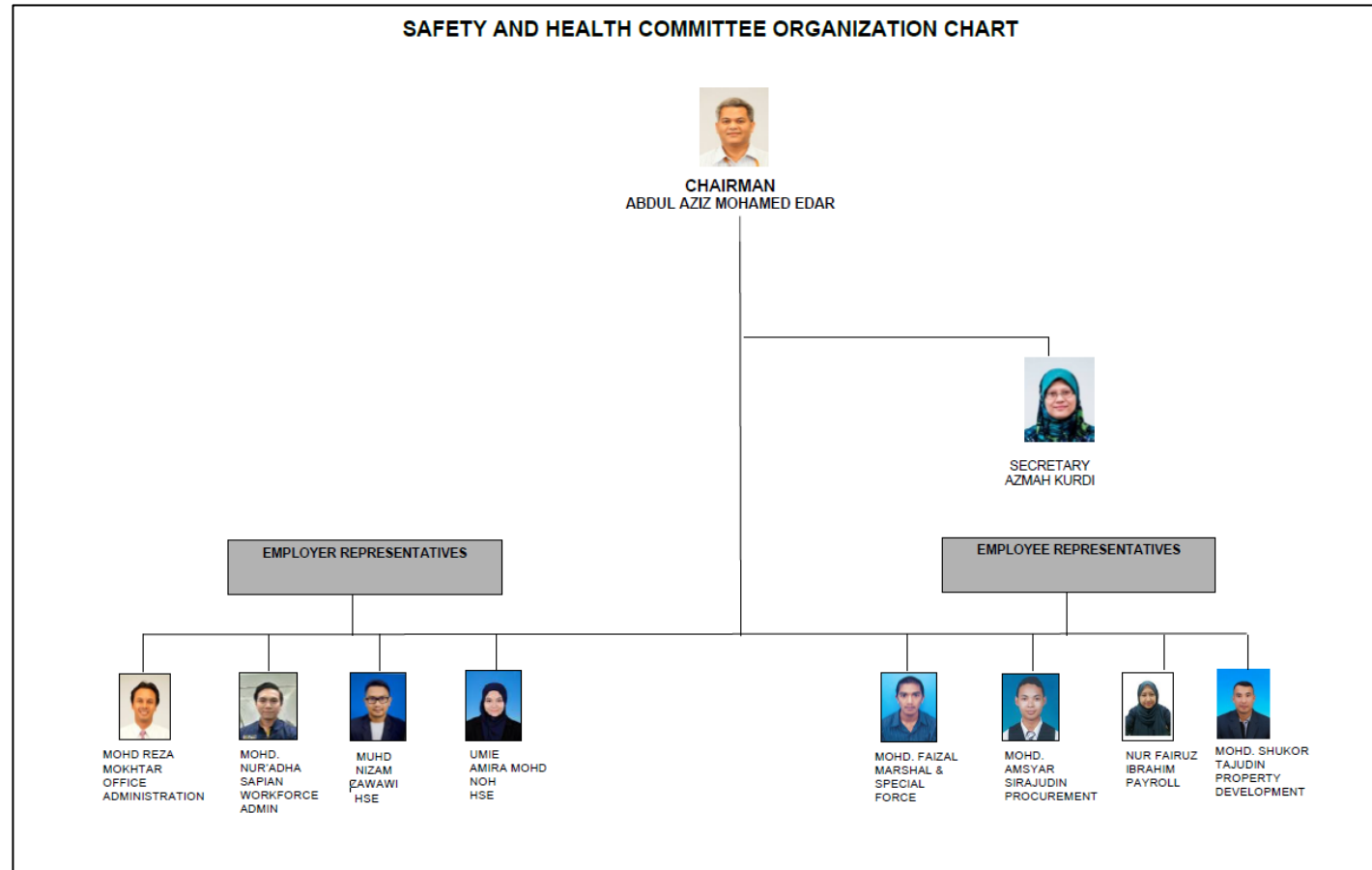

## 2. Safety and Health Committee

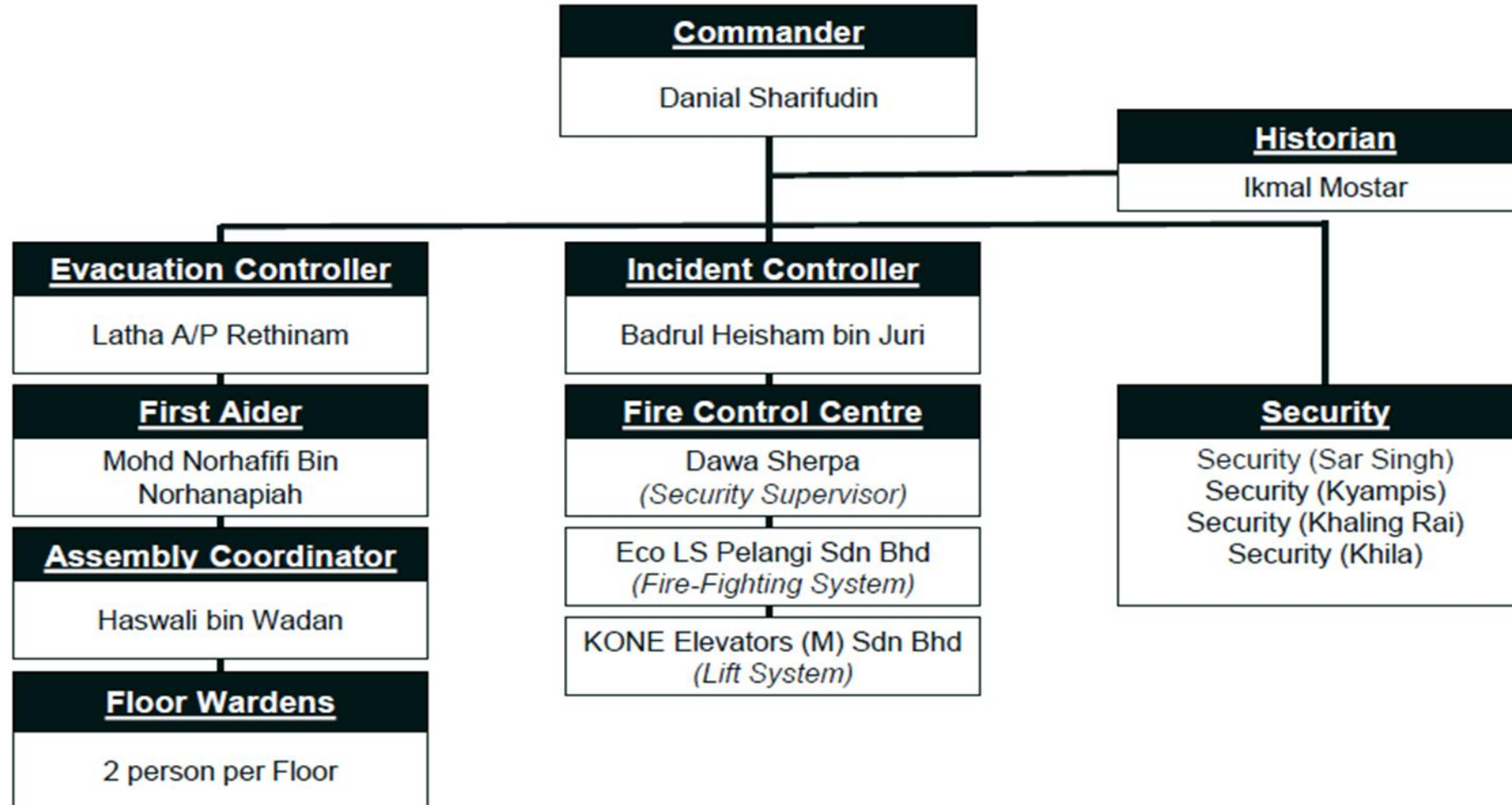


### Functions of the Committee

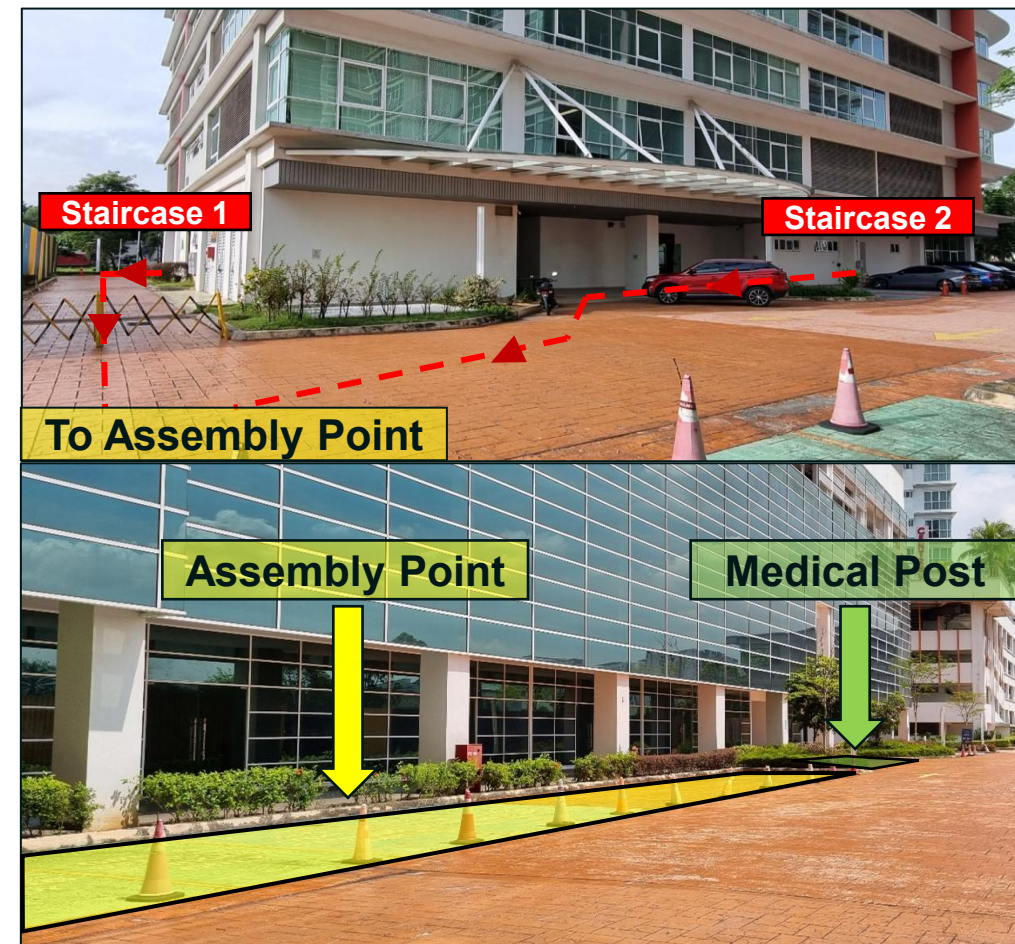
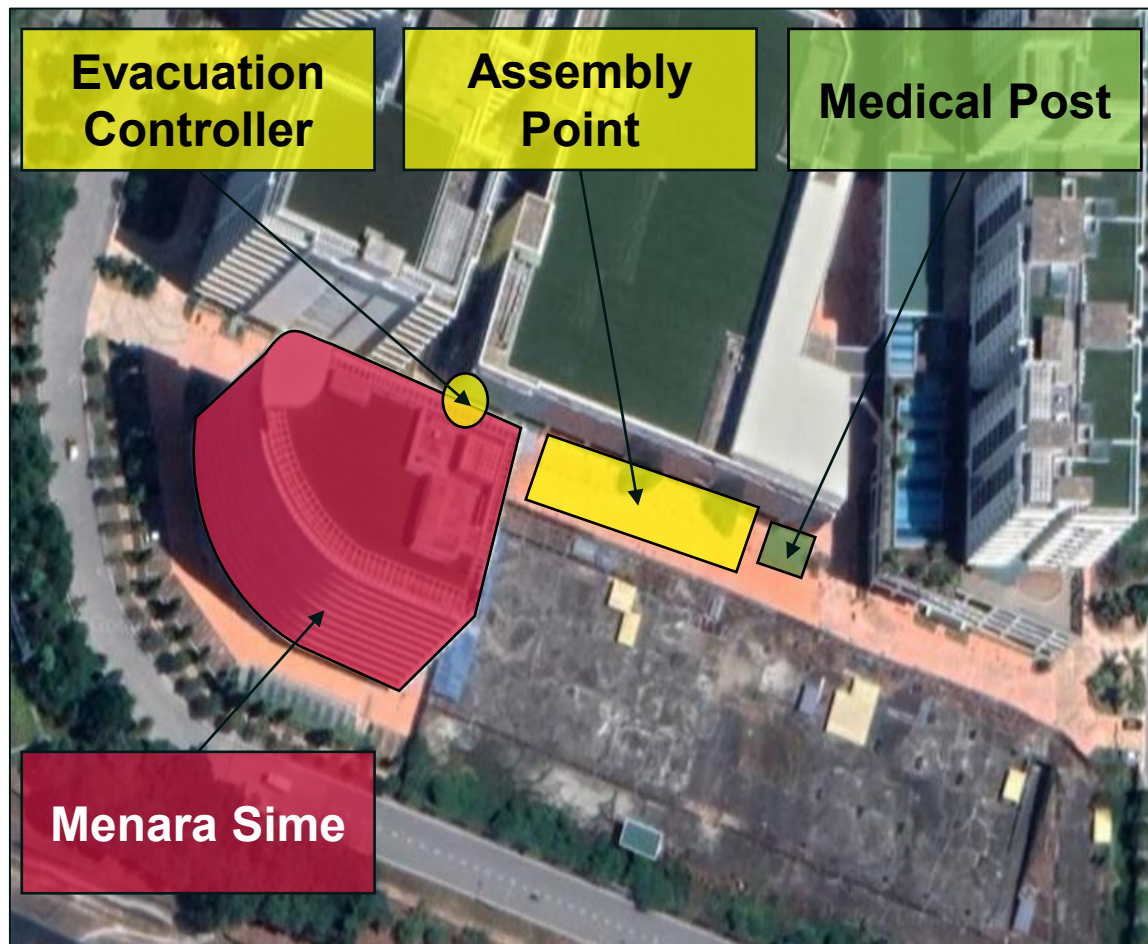
If fire alarm bell is ringing:



- ✓ Do not panic
- ✓ Stop all tasks
- ✓ Walk down the staircase, DO NOT RUN
- ✓ Use the handrail provided
- ✓ Avoid taking your personal belongings
- ✓ Exit the building via the nearest emergency staircase
- ✓ Proceed to the assembly point at open car park from Ground Floor
- ✓ Listen to instructions given by the Evacuation Controller and Security Guards.
- ✓ Do not re-enter the building until further notice

**Manual lifting**

**RISK :** *Health problem such as back pain, slip disk etc.*




**OPPORTUNITIES :** *use trolley, buddy system etc. Provide training / awareness on proper lifting.*

Risk is effect of uncertainty or consequences of an event or “likelihood” of occurrence.
